### **ABOUT**

I am Professor of Urban, Regional and International Economics at the Technical University of Dortmund, Germany. I am a labour and trade economist with a particular interest in creative production. My research has covered a range of topics from agglomeration of economic activity to migration, peer effects, auctions and art markets, economic history as well as international trade of goods and services.

Most of my research employs large, novel datasets based on which aspects of creative production can be quantified and thereby understood better. My most recent research projects explore the role of the internet for international trade in services as well as the production by historic writers.

I have published in journals such as the European Economic Review, the Empirical Economics, Applied Economics Letters, Research in Economics and the Journal of Cultural Economics. Moreover I have contributed to the Wiley Handbook of Genius edited by Dean Keith Simonton and contributed to the VoxEu Blog. I will be on the Board of the Association of Cultural Economics from 2018 to 2020.

I received my PhD from Trinity College Dublin, Ireland, my M.A. from University College Dublin, Ireland, and my B.Sc. in Economics from the University of Maastricht, the Netherlands. I have been a Postdoc at the Economics Department of Heidelberg before I was appointed Assistant Professor in the Department of Economics at the University of Hamburg, Germany.


